RE: Request for Public Hearing and Opportunity to Provide Input on Pennsylvania's Essential Health Benefits Package

In light of the recent ruling of the Supreme Court of the United States regarding the Affordable Care Act, (ACA) it is imperative that Pennsylvania recognize the importance of the state's decision regarding Pennsylvania's Essential Benefits (EHB) package. The EHB decision will have a far-reaching impact on Pennsylvania families, individuals, and small businesses for several years. The EHB is one of the most important regulatory tasks required by the ACA and one that warrants an open and transparent decision- making process. The undersigned groups respectfully request and urge the Pennsylvania Department of Insurance as well as the General Assembly hold public hearings regarding the EHB package as soon as possible.

As you know, each state must identify a "benchmark plan" for the individual and small group markets for plans sold both inside and outside of the exchange. It is to be chosen from one of four categories: 1) The largest of one of the three largest small-group products in the state; 2) one of the three largest state employee plans; 3) one of the three largest Federal Employee Health Benefit Plans; or 4) the state's largest non-Medicaid HMO. The selection will serve as a baseline for the development of Pennsylvania's EHB package, and then additional choices will have to be made if necessary to cover all categories of essential benefits listed in the ACA. The deadline for the state to make a decision regarding its EHB package is fast approaching. If Pennsylvania does not actively make a decision, a default option will apply.

To ensure a transparent and accountable process, consumers and providers must have a voice in the selection of the EHB and continue to provide feedback as the process unfolds in Pennsylvania. Opportunities for consumer input and engagement with state officials and other stakeholders should be pursued by the Insurance Department, the General Assembly, and the Governor's office. We therefore urge you to commit to the first step in an active engagement process by holding a public hearing on the Essential Health Benefits Package in Pennsylvania. It

is also impetrative that prior to a decision that all plan options be made public so that consumers can provide appropriate feedback
